PRACTICE ICE – FRIDAY, SEPTEMBER 14, 2007**

Practice Ice requests must be returned by **August 8, 2007** and will be processed in the order received. However, consideration may be given to skaters from outside the area, traveling from a distance over 150 miles. Singles skaters will be allowed one (1) session per program (i.e., SP, FS, Artistic) if available. Depending on the number of requests received, assigned sessions may need to be limited further or it is possible that additional sessions will be available. Waiting lists will be established for all full sessions. The number of requests will determine dance and pair practice ice sessions. All scheduled sessions are subject to change.

Practice Ice sessions will be approximately 40 minutes in duration [Pair and dance sessions, if assigned, may be shorter with cost to be determined]. Please note that most of the available practice ice time is during school hours. ***At this time it is expected that all Basic Skills through Preliminary events, plus all Adult, Artistic and Solo Dance events will take place on the OLYMPIC rink and all Pre-Juvenile and higher events will be scheduled on the NHL rink. If this changes based on the number of entries, skaters will be given practice ice on the appropriate rink that most closely matches their request(s) below.***

Cost is \$12.00 per session per person. Practice Ice fees will **not** be refunded unless a session is not assigned.
